**TICKETS IN CONSTRUCTION ZONE**

If you receive a citation in a construction zone, with workers present, you are not eligible for Drivers Safety, or Deferred Disposition and your fine will be doubled.

**TICKETS FOR EXPIRED REGISTRATION, INSPECTION, OR DRIVERS LICENSE**

If you receive at citation for the aforementioned items you must submit proof of renewal within 10 days of receiving your ticket to be eligible for a \$20 dismissal fee.

**DRIVERS SAFETY COURSE** You are allowed by law to complete a Drivers Safety Course once per 12 month period. The amount due the court is \$110 along with a copy of your Driving Record, Drivers License, Insurance Card and Certificate of Completion. The court fine is due up front. You have 90-days to complete the course of your choosing at your own expense.

**DEFERRED DISPOSITION** This option is available at the Judge's discretion and requires a \$50 administrative fee in addition to the fine.
