_____ I hereby enter my appearance, and waive my right to a jury trial, and enter a plea of No Contest;

_____ I was not charged with speeding in excess of 24 mph over the posted speed limit and I have confirmed my offense is eligible with the Aurora Municipal Court: (817)636-2783;

_____ I am submitting a photocopy of my valid Texas Driver's License AND proof of financial responsibility in my name, that is valid on the date of this request;

_____ I have confirmed the amount due with the Aurora Municipal Court: (817)636-2783; and I am enclosing the total amount along with my application;

_____ I am not currently in the process nor have I completed a DSC within the 12 months preceding the date of my citation;

_____ I agree to complete a DSC and present to the court, NO LATER THAN 90 DAYS from the date that my request is approved, a certified copy of my driving record from the DPS, AND the "COURT" copy of the DSC certificate;

_____ I understand that my failure to fully comply with these requirements may result in a conviction to my driving record as required by law, and possibly incur additional fees.
